Citizen W. Smolar at 122 Railroad Street stated the first item wrong with the agenda was it was changed from what was originally posted; this is not allowed unless it is done by vote of Council which it has not been done. Mayor Williford acknowledged Mr. Smolar's findings. Second item Mr. Smolar stated 61 Brannon Street property was removed from the agenda, he guessed it was because he made an Open Records request because you all were not following codes. Mayor Williford stated no, it was because there is no official application. Mr. Smolar stated yes that is right, which means no work should have been done on it. Mr. Smolar stated the property was on the agenda to be voted on tonight; Mayor Williford stated, "no, it was only on here for discussion – Mr. Smolar continued to argue loudly. Mayor Williford continued to assure him it was NOT on the agenda for a VOTE, but only for discussion. Mr. Smolar stated therefore, no work should have been done on this topic; Mayor Williford stated once again that no work has been done, only discussion and gather of facts. Mr. Smolar stated the Planning and Zoning Committee had a vote which is illegal. Mayor Williford stated, but we as a Council haven't done anything; Mr. Smolar stated it doesn't matter; I quote from the Whitesburg Code of Ordinance where it states, "neither the Zoning Committee or Planning Commission shall appear or represent any person on any matter pending before the planning commission". I have a letter where they voted on it prior to the Public Hearing. Mayor Williford stated it wasn't an official vote as there wasn't enough present to vote. Mr. Smolar continued to argue that yes there was because it only takes 3 for a Quorum same as the Council. Mayor Williford asks so does Juana vote too? Mr. Smolar stated yes, but then stated well it really doesn't say. Mayor Williford stated we will put it back on the. Mr. Smolar asks How does the Council plan to address this issue? Mayor Williford stated we are waiting on the official application. Mr. Smolar referenced the criteria and standards for considering conditional use permits and how that this property does not meet the standards (proposed use could have an adverse effect on the neighborhood, whether the property could result in a nuisance as defined under state law if not managed properly, property values, traffic/roadway issues, etc.). Mayor Williford stated we have not done anything with the property; and I have done as the City Attorney advised, I believe your 3 minutes is up. Mr. Smolar said okay that's fine; I'll just sit back down and get right back up – Mayor Williford stated that's fine.

Mr. Smolar steps forward to speak on the topic of the City purchasing K-9 or City Police Department; he says the streets in this city are deplorable and you are going to spend \$14,000 for a K-9 dog? Mayor Williford stated we are not spending \$14,000 for a K-9, Mr. Smolar sharply stated, well that's what the quote here states. Councilmember Whitley stated a group was donating \$7,000 towards part of the expense that was needed. Yes, we are discussing Roads and Water Projects every single day and they are a high priority; so no, the K-9 project is not coming in front of these projects but are being done as they are on schedule.

Mr. Smolar said fine, on to the Accounting Software item; I sat on a presentation 2 years ago and this is designed for non-profits and not for city governments. Well, there are other governments using it because I have spoken with them, and they like it, and it is working well. Mr. Smolar is arguing with Councilmember Whitley saying no they aren't and that is not true. Councilmember Whitley ask Mr. Smolar if he isn't happy with the decisions, we are making about the Accounting Software, why did you resign when you could have stayed and made the decision.

Mr. Smolar continues to talk over Councilmember Whitey and says thirdly; the minutes that ya'll approved are erroneous, because you don't have a 4.0 vote on anything you only have a 3.0; Mayor Williford stated we don't have a 4.0 vote; Mr. Smolar stated well that's what the minutes, do you not read the minutes?

Mayor Williford stated, I don't vote unless it's 3 – it's in the minutes and they are erroneous you only had a 3-0 vote!! Mayor Williford stated okay William enough. Councilmember Whitely stated it was an oversight we are not perfect; William stated multiple times while talking over Councilmembers and Mayor it's not about being perfect it's about being right. Mayor Williford stated we will get it corrected.

Mr. Robert Gamble at 54 James Lane, asks what cost the city will incur to train the officer to handle the K-9? Councilmember Lewis stated the total cost was \$14,000 of this the city is paying \$7,000 and the other \$7,000 is coming from an Organization that does this for a lot of other small cities. Danny Salazar will be the trained Officer trained to handle the K-9 and will house it. When the K-9 is on property, it will be kept in a kennel behind the Police Department, as for food we are looking at food donations from city and businesses. Mr. Robert Gamble stated the K-9 will need to be kept cool; Councilmember Lewis stated it will have a cool place to stay. Chief Gilliland stated the Officer training is included in the purchase price. The Officer would be able to handle the K-9 after 30 days of training. Mr. Robert Gamble also posed the question about the liability insurance regarding the K-9 and the City, do we have coverage or not? Chief Gilliland stated he was told by Mr. Smolar last year at one of our meetings that the City Liability Insurance did cover a K-9. Mr. Gamble stated we just need to make certain the city is covered.

Mr. Robert K Arnell at 25 White Oak Street stated his issue was with the dog too; we need this dog like we need these cameras at the school – we don't have enough foot traffic at the school that we need these cameras, it's nothing but a speed trap!! I'm not a camera fan of the government watching what we're doing. It's all going to be a dead expense every month. Councilmember Whitely said I have lived on Main Street for 28 years, and you should know how fast these trucks and cars come flying right past the school ... it is not safe for our children; so, anything that slow them down I am all for it! Yes, it will be an adjustment for everyone. Mr. Arnell stated these cameras are just a bad idea, Councilmember Whitely asked why because you speed through the school zone – he said no, I just don't like it!! Councilmember Whitely stated well we can't just not go with something you don't like it; when there is a very good reason for doing it as it will slow down traffic. At this point there was so much discussion and arguing between Councilmember Whitley, Mr. Robert K Arnell, Mr. William Smolar that I (Assistant Clerk Wanice Odell) was not able to capture clearly who was saying what, but whoever told Councilmember Whitely "**Hush**" was very disrespectful and she deserves an apology! Thank you, Councilmember Lewis, for stating that citizens are to follow the rules of order and come to the podium and state your name and address and keep comments to the 3-minute minimum.


